## Working Groups Forming

The CTAP Theme Working Groups of 2007 will play a significant role in planning the next four years of CTAP activity. The Theme Working Groups have the opportunity to concentrate their resources and energies to address specific activities that will enrich the corridor communities.

The Working Group themes were developed from the strategic planning sessions in 2006. At these sessions the CTAP Community identified 15 goals within four themes that now serve as the building blocks for the long-term goals of CTAP. The four themes are:

- Theme A  
Community Infrastructure
- Theme B  
Environmental Protection, Land-Use, and Open Space
- Theme C  
Downtown/Village Centers and Community Vitality
- Theme D  
Local Economy

Working Group membership is open to the community and new members are encouraged to participate in a theme of their interest.

The Working Groups each hold three meetings to discuss potential longer term strategies and actions and to define a framework for future CTAP programs. The Working Groups will also be responsible for identifying leveraging opportunities for CTAP.

## 15 K Available for All Corridor Communities

CTAP Local Discretionary Funds are now available to the 26 communities in the CTAP corridor. Up to \$15,000 will be provided to communities for projects that are compatible with CTAP's goals, available online at [RebuildingI93.com](http://RebuildingI93.com).

These discretionary accounts are created to meet the needs of CTAP communities and can be used for technical assistance in land use and transportation planning. The RPCs are available to discuss potential projects and advise on the application process if desired.

Communities are not limited to one project. Several projects may be funded for each community under this program provided that the total amount of funding

per community does not exceed \$15,000. There are two options for receiving services and/or funding under this program: a) communities may either manage an approved project themselves, submitting invoices to the RPC, or b) the RPC can manage the project, providing technical assistance to communities that is valued up to \$15,000.

The town of Danville is the first to submit their application for funding under this program. The goal of Danville's proposal is to figure out the nuts and bolts of revitalizing the town's Main Street. If approved, the Town will hire outside assistance to evaluate the current regulations governing land use on Main Street, build consensus within the community on what the

heart of the town should look like in the future, and change existing regulations to accomplish that vision.

Other nearby communities are moving forward on some interesting proposals, too, including a New Boston road corridor study, a feasibility study for impact fees as a tool for managing infrastructure development and future growth, and new zoning amendments based on information from the Natural Services Network.

## Steering Committee Update

At the February 1<sup>st</sup> CTAP Community Meeting, several new Steering Committee members were elected. The vacancies were filled by David Danielson of Bedford, George Sioras of Derry, Steve Henninger of Concord, Michael Vlachich of the Department of Resource and Economic Development (DRED) and Dean Christon of the New Hampshire Housing Finance Authority. These new members' terms will end in 2009.

The newly revamped Steering Committee has more representatives from the communities themselves and fewer from NH state agencies.

At the next Steering Committee meeting in March, the Committee will be moving forward with the next order of business – reviewing the evaluation model that will be used to assess CTAP's ongoing programs over the next several years.

After initial approval from the Steering Committee the CTAP evaluation process will seek input from CTAP communities to determine how successful the Year-One programs have been.

The Steering Committee will also explore new ways of leveraging CTAP's resources and partnering with other communities interested in transportation and land use management.

## Community Assessments Beginning

In addition to discretionary accounts, there is another exciting Year-One program underway, the community assessments. RPCs and local governments will work together to assess each community's present growth planning strategies and to identify needed services to achieve regional goals. The assessments will assist in the selection of future CTAP programs.

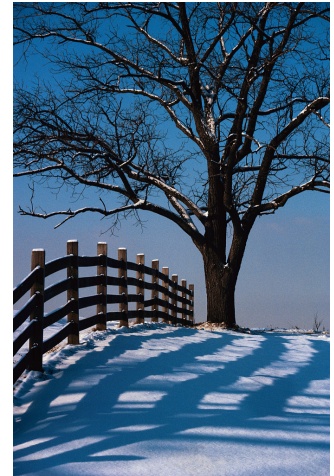
Every corridor community will have the option of participating with the assessments. Assessments will be conducted either by an RPC or a hired consultant, but the communities themselves will decide

their level of participation in the process.

The assessments will be scaled to the size and type of community being evaluated. The assessments are intended to be participatory and conversational, and will consist of several facilitated sessions to provide information to communities and also to ask for their input.

The final document, the Community Planning Assessment Report, will take a comprehensive form, reviewing all of the regulations and plans a town or city has for growth and the findings from various facilitated work sessions, in addition to a

summary report. The assessments are also intended to help communities get the information they need to apply for and spend grant money earmarked for planning and growth practices, such as the local discretionary accounts (see article page 2).



## CTAP Conference Hosted by OEP

The Office of Energy and Planning hosted the CTAP Planning Conference at the Radisson Hotel in Manchester, on Saturday, December 2, 2006. Over 100 people from local communities, regional planning commissions, and other organizations attended the day-long event. The conference provided training for land use board members of the CTAP community.

The conference was a great success. The event was a collaboration between several groups that are involved in helping

I-93 expansion communities plan for growth, including the NH DOT, The New Hampshire Local Government Center, Clough Harbour & Associates LLP, and Antioch New England Institute.

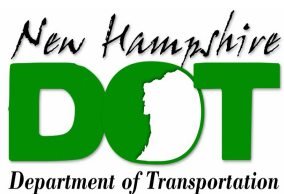
