- Maintains a central file of local land use regulations as required by RSA 675:9;
- Maintains and regularly updates a database on the status of municipal planning and land use regulations in New Hampshire;
- Maintains and regularly updates an electronic <u>reference library</u> of various planning topics and subjects;
- Administers the <u>Plan-link</u> email listsery, an on-line discussion and information sharing forum for the New Hampshire planning, zoning and land use regulation community;
- Develops and presents training programs for local land use boards and Regional Planning Commissions in accordance with State statutes; and
- Provides technical assistance to communities in special areas such as water resource protection planning, wetlands protection, floodplain management and smart growth.
